This may include, but is not limited to, children who are homeless, orphans (whether in the care of an orphanage or not), suffering from illness (including, but not limited to TB, AIDS, malaria, leprosy, typhoid, polio, black fever, and measles), malnourished or dying.

Reporting requirements.

- Grantee agrees to provide Baal Dan with written reports no less than twice per year of the use of Baal Dan funds and/or goods and/or copies of the attached "Distribution Accountability" form to Baal Dan.
- If Grantee purchases goods with Baal Dan funds, the reporting should include copies or originals of receipts for all of the goods purchased.
- Grantee should retain such original receipts for at least one year after a distribution is made.
- Baal Dan has the right to review any and all such receipts and any related documentation.
- If Grantee fails to comply with the reporting requirements, Baal Dan may discontinue any future contributions of funds or goods.
